#### SC 098 23 Planning Matters for meeting on 7<sup>th</sup> August 2023

P/21/2154/2 Proposed change of use of land on 3 Turns Lane to livery business with associated equestrian buildings including shelter (retrospective), 2 No stables (retrospective) and hay store as well as 3 No stables and backroom and temporary siting of tourer caravan to provide toilet facility and storage container (part Retrospective). Dear Resident

Welcome to July's Priority update for the Melton Rural South Beat. Our priorities are decided from feedback from the community in the form of surveys through Neighbourhood Link and our crime incident reporting systems.

Thank you to those who have completed the surveys.

Our 3 main priorities are:

Road Safety

**Drug Taking** 

Rural and Farming Equipment Thefts

We had a great deal of rain in July and we had 5 Road Traffic Collisions (RTCs) on the Melton Rural South Beat, tragically one of which resulted in a fatality. This brings into sharp focus the need to drive within the speed limit and to the weather conditions through our villages and on our local roads.

There were 2 thefts from vehicles on our beat. Please ensure your vehicle is secure when unattended and any valuables are out of sight, ideally in the boot.

We have seen 3 burglaries across the beat involving thefts from a building site, a diesel theft from agricultural vehicles and a residential burglary.

We continue to develop intelligence on drug dealing and are proactively conducting stop/search of suspect vehicles.

Councillors resolved to accept the quotation for provision of a pathway from the carpark to the higher level on the playing field. Of 3 quotations requested one failed to respond with detail and a second withdrew due to staffing problems.

Councillors resolved to accept the quotation from the arborist for £450.00 to assess the condition of the trees around the playing field.

A Street Lighting consultation has been run between 6<sup>th</sup> July and 3<sup>rd</sup> August following LCC's identification of budget savings. Councillors did not agree with the proposed further dimming of lights.
