#### SC 205 24 ACV – Outcome

The Parish Council meeting was attended by a representative 16 members of the public aggrieved by the decision of Charnwood Borough Council to uphold an appeal and allow the Asset of Community Value (ACV) on the Golden Fleece listing to be removed.

A broad range of discussion ensued which evidenced the strong feelings concerning the loss of a longstanding amenity in the Village, condemned the undemocratic decision by Charnwood, and the haste with which the decision was made without any involvement of the community or Parish Council . The feeling is that the decision should be challenged.

It was established that the Parish Council would not be allowed to submit a second ACV, however, under legislative rulings a second ACV under a qualifying group was a possibility. Councillors warned that the initiative would involve a considerable and sustained effort on the part of the qualifying group.

The possibility of a judicial review was mooted, and/or an approach to a higher executive within Charnwood Council. Three possible ideas emerged from the meeting:

- 1. The Parish Council could commit to following a Complaint Process.
- 2. The community should strongly resist any application by the owners for change of use of the property.
- 3. Re- application through a community group (unconnected with the Parish Council) which would need a constitution and a bank account is a viable route to follow.

It is anticipated that further action will be made outside of the Parish Council meeting.

Charnwood Council Report to South Croxton Parish Council- March 2024

The Charnwood Draft Plan has been further examined by the Government appointed Planning Inspector during 4 days of hearings at the town hall in Loughborough. I attended on Thursday morning when travel was one of the areas that was being looked at in more detail. A final decision on the plan is expected in the Autumn.

Although the flooding seems to have happened a while ago now, many residents are still experiencing the side effects. The Government has announced payments for communities effected by flooding caused by Storm Henk. The support is being made available through a scheme called the Flood Recovery Framework and is being administered by Charnwood Borough Council.

- Community Recovery Grant £500 for immediate recovery costs.
- Council Tax Discount 100% Council Tax relief for at least three months.
- Business Recovery Grant £2,500 to help return to business as usual.
- Business Rates Relief 100% relief for at least three months.

These measures aim to provide immediate relief and support to those effected by the floods in Charnwood. The deadline for applications is set at Thursday March 21<sup>st</sup>, 2024. Apply online. There is a meeting scheduled for 20<sup>th</sup> March in Syston to give residents the opportunity to raise flooding related issues with CBC representatives.

Charnwood Borough Council approved a budget increase of 3%. Charnwood receives only about 7% of the council total tax bill, the remainder is spent by the County Council, the emergency services and Parish Councils. The Charnwood part of council tax will rise by £4.21 ( 3% ) for an average band D property from April 1, 2024. The Charnwood budget includes the creation of a £100,000 grants fund to support community groups who help residents struggling with the cost of living .

A 5% council tax rise has been approved by Leicestershire County Council at their annual budget meeting. There is a 3% rise in general funding and a 2% rise in funding for social care.
