SC 122 23 County and Borough Councillors' Reports

Cllr O'Neil made his report to the meeting followed by Cllr Seaton. A copy of Cllr O'Neil's report is attached at the end of these minutes.

Cllr Seaton – covered the issue of new housing in the area of Queniborough and Thurmaston with concerns about the Southern Link Road. Discussion also ensued regarding rights of way and responsibility for footbridges. It was also noted that formal rights of way must be established by 2025 for a lane not currently registered. Details need to be notified with the Access Officer, Safe and Sustainable Travel Team, in Leicestershire County Council. Maps were offered by Cllr Newbery showing the route and Cllr Seaton offered to provide details and history of the area concerned. The Clerk will then communicate with the Access Officer to progress the matter.
